Hanover Community Television (HCTV) exists to give the public access to the communication medium of television. The public includes all individual who live, work or have tax payer status in Hanover, and to all organized groups with offices in Hanover. Hanover Community Television accepts various types of information and expression and welcomes a diversity of views.
