Chair Dockter called the meeting to order at 6:03 PM. There were 6 members present and 2 absent.

There were no public comments.

The motion was seconded. The motion passed unanimously to accept the forty-seven (47) Town Meeting Articles commentaries via roll call vote.

The Chair shared that at the next meeting would be on Monday, May 2<sup>nd</sup> at 6:30 for last minute town meeting discussion and accepting the minutes from the 4/13/22 meeting.

Chair Dockter asked the committee what worked or didn't work this year. He asked the committee to give this question some thought and share their thoughts with him.
